

### What is the Disability Royal Commission?

The Disability Royal Commission was established in April 2019 in response to community concern about widespread reports of violence against, and the neglect, abuse and exploitation of, people with disability. These incidents might have happened recently or a long time ago. The Disability Royal Commission is investigating:

- preventing and better protecting people with disability from experiencing violence, abuse, neglect and exploitation
- achieving best practice in reporting, investigating and responding to violence, abuse, neglect and exploitation of people with disability
- promoting a more inclusive society that supports people with disability to be independent and live free from violence, abuse, neglect and exploitation.

The Disability Royal Commission gathers information through research, public hearings and the personal experiences people talk about in submissions, private sessions and other forums.

The Disability Royal Commission will deliver a final report to the Australian Government by September 2023.

### Introduction to support services

You might need support from a counsellor or an advocate if you:

- have ever been hurt, treated badly or taken advantage of
- are thinking about taking part in the Disability Royal Commission.

This booklet includes information on free and independent counselling, advocacy and legal support services available to help you.

These support services are funded by the Australian Government.

### National Counselling and Referral Service

To find out more about how you can get support you can contact the National Counselling and Referral Service on 1800 421 468. You can get emotional support or ask to be connected to a disability advocate, counsellor or legal service near you.

It is available 9am to 6pm weekdays, and 9am to 5pm weekends and national public holidays.

The National Counselling and Referral Service is run by Blue Knot Foundation, an organisation which is independent from the Government and the Disability Royal Commission.

There are also a number of other organisations across Australia funded to deliver independent advocacy, legal and ongoing counselling services. These services include face-to face, mediumterm, trauma-informed counselling for people with further needs.

The National Counselling and Referral Service may refer you to these organisations where needed or you can contact these organisations directly.

### Counselling—it could be for you

Have you experienced or witnessed someone being hurt, treated badly or taken advantage of? Are you or is someone you know thinking of telling their story to the Disability Royal Commission? You may feel that you need emotional support.

Free, independent and confidential counselling support is available to help you.

Counselling support can help you whether you are a person with disability, family member, carer, support worker or advocate of someone with disability.

You can access counselling in a number of ways and this will depend on the organisation you contact. These include talking over the phone, meeting face to face, online chat and video call.

A counsellor can support you to:

- discuss your feelings and emotions in a safe and confidential environment
- understand more about what has happened to you and how it has affected you
- find ways to think about a problem or issue
- make choices about telling your story to the Disability Royal Commission
- find other practical supports available to you.

You can take your time to think about getting support. It's here for you when you are ready.

To receive emotional support and find out more about how you can get ongoing support you can contact the National Counselling and Referral Service on 1800 421 468 and ask to be connected to a counsellor near you.

### **Counselling explained**

Counselling is another word for 'emotional support'. Emotional support is about having a safe space where you can be listened to, heard, validated and believed.

Counselling can help you to make sense of things that have happened to you or that you have seen, and work through how they have affected you.

Many people think that counselling is just for people with mental illness or may feel ashamed about needing it, but counselling is for everyone.

If you have been treated badly, you may find it difficult to feel safe sharing your story with someone you don't know. This is understandable. Counsellors providing support are experienced in working with people with disability and those who have experienced trauma.

Counselling is confidential and independent. This means that your information is kept private and your counselling is not part of the Government or the Disability Royal Commission.





### Meeting with a counsellor

Going to counselling can make some people anxious. Preparing for your first counselling session can help reduce some of the anxiety you might have. Getting ready for your session could involve thinking about what you want to talk about and what you want to get out of the session, or even writing things down. It is important to remember that you may not be able to say everything in one session and can have more if you find it useful.

You are welcome to have a support person such as a family member, friend or support worker present at your counselling sessions, whether that be over the phone or in person.

Getting support does not mean you have to take part in the Disability Royal Commission – it is your choice.

### Advocacy – help for you to speak up

If you have been hurt, treated badly or taken advantage of and are thinking of telling your story to the Disability Royal Commission, you may feel that you need support.

Advocacy support is for people with disability who have difficulty communicating or need assistance to understand how to engage with the Disability Royal Commission. This service is also available to family members or carers acting on behalf of someone with disability.

Advocacy support is free, independent and confidential.

An advocate can help you to:

- protect your rights
- work out problems
- · find communication supports
- access other supports such as legal or financial services.

You can take your time to think about getting support. It's here for you when you are ready.

To find out more about how you can get advocacy support you can contact the National Counselling and Referral Service on **1800 421 468** and ask to be connected to an advocate near you.

### **Advocacy explained**

An advocate is a support person that can help you speak up when you can't speak up for yourself. They can also help family members or carers acting on your behalf to help you tell your story.

An advocate can help you to understand and participate in the process of telling your story to the Disability Royal Commission if you want to, and talk about options to tell your story.

Advocates are independent – they are not part of the Government or the Disability Royal Commission.

An advocate will also not make decisions for you or tell you what to do. It is your decision if you want to tell your story to the Disability Royal Commission and how you would like to do that.

They can help you tell your story in any way that feels comfortable for you. You can draw it, write it down, tell it over the phone, or they can type it out for you.

### Meeting with an advocate

An advocate might be able to come and see you in person or chat with you over the phone or through a video call.

They can also organise communication supports such as an Auslan interpreter if you need.

You are welcome to bring a family member or friend if you do not want to see an advocate alone. A counsellor can also be present to support you during an appointment with an advocate.

Your advocate is there for as long as it takes you to decide to participate in the Disability Royal Commission (or not) and share your story.

You do not need to do anything before you talk to an advocate. If it helps you, you can start thinking about or writing down what you want to talk about

Most people can expect to work with the same advocate throughout their journey. However, you are welcome to ask to change to a different advocate if you are not comfortable with the one you start with.

Getting support does not mean you have to take part in the Disability Royal Commission – it is your choice.





### **Your Story Disability Legal Support**

Your Story Disability Legal Support can support you to share your story with the Disability Royal Commission. The service gives free, confidential legal advice and support and is independent from the Disability Royal Commission.

Your Story Disability Legal Support can work with you to:

- decide how to tell your story
- support you to make a submission to the Royal Commission
- support you in a private session with the Royal Commission
- support you before, during and after you tell your story
- connect you with counselling and advocacy support.

If the service can't help you solve your legal or non-legal problem, they will connect you with someone who can. Our social worker can also support you to tell your story.

Your Story Disability Legal Support is a national service that supports people with disability, their family, friends, carers, supporters and advocates. If you are an Aboriginal or Torres Strait Islander person, we can connect you with an Aboriginal legal service.
