

Township Residents

A kerbside hard waste collection service will be provided for township residents for the removal of large items that cannot be disposed of through regular household waste collections. For a residential property to be eligible they must be located within township boundaries, which is defined as having a street address, not a rural address. Excluded properties include, but are not limited to; businesses, commercial premises, vacant land, industrial properties, schools and churches.

Preparing for your collection

Hard waste items must be sorted and placed in sorted piles on the nature strip in front of your property on the Sunday before your collection week.

Your total collection should not be more than 2m³ (two cubic metres). Items must be no longer than 2 metres and must be able to be lifted by two people. Hard waste exceeding these limits will not be collected.

All collections will be from an accessible kerbside position located outside the premises, close to the kerb line and clear of the road and footpath. Please avoid parking in front of collection piles.



Time frames and collection zones:

Kerbside collection of hard waste will be undertaken within a 6 week period.

Uncollected items/early presentation:

To prevent the townships from looking untidy during this time, residents will be required to place items for collection out on the Sunday of the week of collection.

Early placement may attract a fine under the Local Nuisance and Litter Control Act.

Cleanaway may elect to not collect waste if the following occurs:

- Additional amount beyond the allowable limit (2m³) is presented
- Excluded materials are presented

Cleanaway will provide written notice to the resident if any waste is left uncollected.

Uncollected items must be removed within 24 hours. It is the residents responsibility to do this and failure to do so may attract a fine.

*Scavenging is not permitted

IMPORTANT INFORMATION FOR RESIDENTS



The Berri Barmera Council is providing a hard waste collection and a hard waste disposal opportunity for all residential properties within the Berri Barmera Council district.

My Collection Week is :

Rural Residents

Rural residents will be eligible for a single use voucher to the value of \$50 for use at the Cleanaway Waste Transfer Station in Monash.

Vouchers will be available from the Berri Council Office located at 19 Wilson Street. To obtain a voucher, a copy of a Council rates notice or a driver's licence is required to be shown as proof of residency within the Council area.

Council residents can also provide identification at the Barmera Public Library located at 4 Barwell Avenue, Barmera, and a voucher will be mailed out.

To be eligible for a voucher the property must be a residential property with an allocated rural address.

Please note only one voucher per eligible property can be claimed and any charges above this amount will be at the cost of the resident (at the current disposal rates).

Hard Waste Items

Items that **will** be collected:

- Medium to large general waste items able to be handled by two people
- Empty paint tins with lids removed
- Furniture, bedding (no mattresses), carpets, rugs and mats
- Non-metal and non-electrical tools and gardening equipment
- Polystyrene and other plastic packaging
- Pottery, crockery and wash basins
- Pyrex glass (e.g. microwave dishes) and intact mirrors
- Hot water units, tanks and empty drums able to be handled by two people
- Lawn mowers, small combustion equipment, metal tools and gardening equipment
- Metal baths, roofing iron and guttering up to 2 metres in length and able to be handled by 2 people
- Small metal car parts weighing less than 20 kilograms
- Any other scrap metal material
- Fridges and freezers with doors removed
- Washing machines, dryers and stoves

Hard Waste Items

Items that **will not** be collected:

- E-WASTE - please refer to Council website for listing of items.
- Mattresses
- Cans or tins containing liquid paint or other liquids
- Car bodies, large car parts, tyres or large scrap metal items above 2 metres and/or unable to be handled by 2 people
- Concrete, asbestos, bricks, rocks, dirt
- Items placed in plastic bags that appear to be hazardous in nature
- Gas bottles, ammunition or explosives
- Domestic recyclables such as glass and plastic bottles, jars and other containers suitable for collection through the kerbside comingled recycling collection service
- Large sheeting and plasterboard sheeting unable to be handled by 2 people
- Liquid waste
- Obvious business waste (e.g. large volumes of identical material or items)
- Other hazardous waste items as defined under the Environment Protection Act
- Large tree stumps unable to be handled by two people
- Treated pine
